Background Information - Grass Cutting Within West Lancashire

Introduction

The Borough has approximately 1.5 million square metres of open public land which is maintained by the West Lancashire Borough Council. In 2007, the contract for the maintenance of these public areas was awarded to Street Scene.

Grassed Area

Each grassed area within the Borough is assigned a category that will determine the number of cuts it will receive per season (see table 1). However, due to the area location, the grass may be assigned more than one category. A typically example is

There are twelve different grass cutting categories that are employed throughout the Borough, as shown in table 1.

Each of the categories has a specific schedule of rates which incorporate labour, machinery, and material charges that are required to carryout the grass cutting task.

Grass Cutting Season

The grass cutting season commences in early April and concludes late October. The cutting schedule can be severely affected by the weather

conditions as we have recently experienced. This has resulted in areas of the Borough not receiving the specified number of cuts due ground conditions.

Highways

It is the responsibility of Lancashire County Council to cut the grass on verges where it impairs traffic sight-line visibility. However, in partnership with the County, Street Scene undertakes this work with funding from the County Council. The partnership arrangement with the County Council also involves the grass cutting of verges along rural lanes.

Such areas are extremely hazardous to carryout grass cutting maintenance and require specific traffic management control measures. This ensures the safety of our staff and road users whilst the task is being undertaken.

Leisure

All Council owned grassed amenity areas within the Borough are maintained by Street Scene. These areas include football pitches, bowling greens, cricket pitches, parks and play areas. Where appropriate, pitch line markings are also applied in agreement with Leisure Services.

Street Scene liaises closely with the Leisure Services, administration team with regards to the re-scheduling or additional grass cuts, and receiving feedback from the end users including affiliated clubs.

Housing

Street Scene cut the grassed areas within all the estates owned by the Council on behalf of the Housing Section. The grassed areas within sheltered housing are also cut though this differs as the specification requires these cuttings to be removed.

Cemeteries

Street Scene maintain the grassed areas within the cemeteries at Liverpool Road, Skelmersdale and St Paul's Skelmersdale for which the Council has responsibility.
