Application to the Secretary of State for a Direction to save the policies of the West Lancashire Replacement Local Plan beyond July 2009

### 1. Executive Summary

The West Lancashire Replacement Local Plan ("the Replacement Plan") was prepared under the Transitional Arrangements of the 2004 Act, and adopted on 5 July 2006. It was originally envisaged that a Local Development Framework (LDF) would essentially be in place in the District by July 2009. However, this has not turned out to be the case, and thus West Lancashire District Council is applying for a Direction to save the policies of the Replacement Plan beyond July 2009 (three years after the Plan's adoption).

This report lists the policies that are proposed to be saved beyond July 2009, and those that are proposed not to be saved beyond that date. It analyses each of the Replacement Plan policies against the government criteria for saving policies, thus providing a justification for the saving (or otherwise) of each policy.

It is proposed that the majority of the Plan's policies (46 out of 49) be saved.

#### 2. Criteria for saving policies

The six criteria against which policies are to be assessed are set out in Planning Policy Statement 12 paragraph 9.2 as follows:

- (1) Where appropriate, there is a clear central strategy;
- (2) The policies have regard to the Sustainable Community Strategy;
- (3) The policies are in general conformity with the Regional Spatial Strategy;
- (4) The policies are in conformity with the adopted LDF Core Strategy (if it exists);
- (5) There are effective policies for any parts of the authority's area where significant change in use or development of land or conservation of the area is envisaged;
- (6) The policies are necessary and do not merely repeat national or regional policy.

In addition, PPS12 lists a number of other factors to which the government will have particular regard when considering extensions to saved policies. These include supporting the delivery of housing, defining Green Belt boundaries, supporting economic development, regeneration and town centres, and reducing impacts on climate change. Where any of these factors are applicable to a particular policy, they are mentioned in the "any other relevant comments" section of the assessment in Section 3 below.

With regard to Criterion (1), it is considered that the Replacement Plan has a clear central strategy. Early drafts of the Replacement Plan were drawn up while the proposals for the new planning system were being consulted upon, and the Re-Deposit version was prepared in autumn 2004, after the enactment of the new system. Thus the Council was aware of the LDF system when putting together the Replacement Plan, and this is reflected by the inclusion of a "Core Strategy" section (Chapters 2 and 3) which contains a vision for West Lancashire, key aims and objectives, and seven policies (DS1-DS4 and GD1-GD3) whose purpose is to facilitate achieving the aims and objectives. The other policies in the Plan also conform to and support the "Core Strategy" section, and thus it is considered that each policy satisfies the first criterion of there being a clear central strategy.

Criterion (2) relates to the Sustainable Community Strategy. The Replacement Plan as a whole has regard to the 2003-2006 Community Strategy, making reference to it in Chapter 1. The Planning Policy Manager was involved in the drafting of the 2007 Sustainable Community Strategy (which has replaced the Community Strategy), and has ensured that this is in accordance with the Replacement Plan.

Criterion (4) refers to the Core Strategy, where adopted. The West Lancashire Core Strategy is currently at a very early stage of preparation, with adoption not expected before 2011, and thus this criterion does not apply in the analysis below.
