- C. That live music shall not be permitted on consecutive days, except where the licensed hours are continuous from one day to another (i.e. Christmas Eve into Christmas Day, which crosses midnight).
- D. That live music by amplified instruments under the authority of the premises licence be permitted on no more than 26 occasions per calendar year.
- E. That all amplified music must be channelled through the noise limiter installed in the function room.
