8. APPLICATION FOR A REVIEW OF A PREMISES LICENCE IN RESPECT OF PLOUGH & HARROW, ORMSKIRK ROAD, SKELMERSDALE

Consideration was given to the report of the Assistant Director Community Services as contained on pages 35 to 60 of the Book of Reports in respect of an application for the review of a Premises Licence in respect of the Plough and Harrow, Ormskirk Road, Up Holland, Lancashire.

In considering this matter the Sub-Committee had regard to its Licensing Policy and to the Guidance issued under S.182 of the Licensing Act 2003. It considered the relevant Licensing Objective on this occasion was the 'prevention of public nuisance'.

On hearing evidence from the Applicant, members of the public and Lancashire Constabulary into consideration the Sub-Committee :-

RESOLVED: A. That in line with the Authority's Statement of Licensing Policy the Sub-Committee issued a yellow card warning which will remain on the licence for a period of 5 years and that the decision of this Sub-Committee be displayed on the premises detailing the outcome of the review and the warning that had been given.

- B. That the Designated Premises Supervisor shall be on the premises at all times when regulated entertainment is occurring.
- C. That regulated entertainment shall be permitted between 19:00 and 23:00 hours Friday and Saturdays.
- D. That a tamper proof CCTV System shall be installed, maintained and operated at the premises in liaison with and to the satisfaction of Lancashire Constabulary and shall be used to record during all hours that the premises are open to the public.
- E. Any image reasonably requested by any responsible Authority shall be downloaded from the CCTV system and provided to that Authority within 48 hours.
- F. That noise from music and associated sources (including DJ's and amplified voices) shall not be audible at the boundary of the licensed premises.
- G. That the premises shall operate an incident/refusal register to the satisfaction of Lancashire Constabulary. This shall be made available for inspection by any responsible authority upon reasonable request
