**39. LICENSING ACT 2003 - EARLY MORNING RESTRICTION ORDERS**

Consideration was given to the report of the Assistant Director Community Services as contained on pages 207 to 218 of the Book of Reports to determine a formal request for an Early Morning Restriction Order for the Ormskirk area.

The Commercial, Safety and Licensing Manager outlined the report and responded to questions from Members of the Committee. He also asked Members to name any specific or particular organisations they wished to be included in the process should they resolve to gather preliminary evidence in respect of a proposed Early Morning Restriction Order.

Members discussed the formal request to consider or dismiss an Early Morning Restriction Order for the Ormskirk area.

Members suggested that the following organisations should be consulted in the preliminary information gathering process:-

- Residents Associations
- Edge Hill University
- Local Businesses
- Takeaway Establishments
- Pubwatch
- Neighbouring Local Authorities
- Responsible Authorities stated under the Licensing Act 2003
- Local Transport//Taxi Services/Transport Police
- West Lancashire Community Safety Partnership

The Committee listened to audio files received from Derby Ward Residents, which were presented by Councillor Owens as an indication of the nature of the problems experienced in the area.

RESOLVED: That the Assistant Director Community Services be instructed to gather preliminary evidence in respect of a proposed Early Morning Restriction Order for the Ormskirk area including the views of partner agencies and available alternative options for presentation to the Licensing and Gambling Committee.
