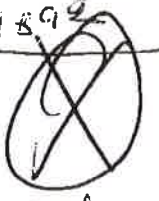

She rang Mary the next day , Mary rang the neighbourhood police, left an answer on the answering machine . 24 later she was contacted, and someone will come out , probably on sunday to speak to the committee member.
