Details Details As Chairman of the Trustees of Hesketh Bank Community Centre, can I please provide an update to the Consultation Feedback Summary Report, which appears on Page 4 of Appendix A? The update will detail the decision of the Trustees to change their plans for a replacement Community Centre Building and their intention now to site the replacement building on the footprint of the existing Back Hall. This decision was announced at a second Public Consultation Meeting on 2nd December 2019 and will allow for the retention of the Band Hut on the existing site, the retention of the Multi Use Games Area (Ball Court) and will not now involve the sale of the Community Centre land for, housing. As a result I am pleased to report that all or most of the objectors are now supportive of the proposal and I understand that some have written to WLBC to rescind their letters of objection.
