**FIRE EVACUATION PROCEDURE FOR:  
COUNCIL MEETINGS WHERE OFFICERS ARE PRESENT  
(52 DERBY STREET, ORMSKIRK)**

**PERSON IN CHARGE:** Most Senior Officer Present  
**ZONE WARDEN:** Member Services Officer / Lawyer  
**DOOR WARDEN(S)** Usher / Caretaker

**IF YOU DISCOVER A FIRE**

1. Operate the nearest **FIRE CALL POINT** by breaking the glass.
2. Attack the fire with the extinguishers provided only if you have been trained and it is safe to do so. **Do not** take risks.

**ON HEARING THE FIRE ALARM**

1. Leave the building via the **NEAREST SAFE EXIT**. **Do not stop** to collect personal belongings.
2. Proceed to the **ASSEMBLY POINT** on the car park and report your presence to the **PERSON IN CHARGE**.
3. **Do NOT** return to the premises until authorised to do so by the **PERSON IN CHARGE**.

**NOTES:**

Officers are required to direct all visitors regarding these procedures i.e. exit routes and place of assembly.

The only persons not required to report to the Assembly Point are the Door Wardens.

**CHECKLIST FOR PERSON IN CHARGE**

1. Advise other interested parties present that you are the person in charge in the event of an evacuation.
2. Make yourself familiar with the location of the fire escape routes and inform any interested parties of the escape routes.
3. Make yourself familiar with the location of the assembly point and inform any interested parties of that location.
4. Make yourself familiar with the location of the fire alarm and detection control panel.
5. Ensure that the zone warden and door wardens are aware of their roles and responsibilities.
6. Arrange for a register of attendance to be completed (if considered appropriate / practicable).

**IN THE EVENT OF A FIRE, OR THE FIRE ALARM BEING SOUNDED**

1. Ensure that the room in which the meeting is being held is cleared of all persons.
2. Evacuate via the nearest safe Fire Exit and proceed to the **ASSEMBLY POINT** in the car park.
3. Delegate a person at the **ASSEMBLY POINT** who will proceed to **HOME CARE LINK** in order to ensure that a back-up call is made to the **FIRE BRIGADE**.
4. Delegate another person to ensure that **DOOR WARDENS** have been posted outside the relevant Fire Exit Doors.

5. Ensure that the **ZONE WARDEN** has reported to you on the results of his checks, **i.e.** that the rooms in use have been cleared of all persons.
6. If an Attendance Register has been taken, take a **ROLL CALL**.
7. Report the results of these checks to the Fire and Rescue Service on arrival and inform them of the location of the **FIRE ALARM CONTROL PANEL**.
8. Authorise return to the building only when it is cleared to do so by the **FIRE AND RESCUE SERVICE OFFICER IN CHARGE**. Inform the **DOOR WARDENS** to allow re-entry to the building.

**NOTE:**

The Fire Alarm system will automatically call the Fire Brigade. The purpose of the 999 back-up call is to meet a requirement of the Fire Precautions Act to supplement the automatic call.

**CHECKLIST FOR ZONE WARDEN**

1. Carry out a physical check of the rooms being used for the meeting, including adjacent toilets, kitchen.
2. Ensure that **ALL PERSONS**, both officers and members of the public are made aware of the **FIRE ALERT**.
3. Ensure that **ALL PERSONS** evacuate **IMMEDIATELY**, in accordance with the **FIRE EVACUATION PROCEDURE**.
4. Proceed to the **ASSEMBLY POINT** and report to the **PERSON IN CHARGE** that the rooms within your control have been cleared.
5. Assist the **PERSON IN CHARGE** to discharge their duties.

It is desirable that the **ZONE WARDEN** should be an **OFFICER** who is normally based in this building and is familiar with the layout of the rooms to be checked.

**INSTRUCTIONS FOR DOOR WARDENS**

1. Stand outside the **FIRE EXIT DOOR(S)**
2. Keep the **FIRE EXIT DOOR SHUT**.
3. Ensure that **NO PERSON**, whether staff or public enters the building until **YOU** are told by the **PERSON IN CHARGE** that it is safe to do so.
4. If anyone attempts to enter the premises, report this to the **PERSON IN CHARGE**.
5. Do not leave the door **UNATTENDED**.

A Member with a disclosable pecuniary interest in any matter considered at a meeting must disclose the interest to the meeting at which they are present, except where it has been entered on the Register.

A Member with a non pecuniary or pecuniary interest in any business of the Council must disclose the existence and nature of that interest at commencement of consideration or when the interest becomes apparent.

Where sensitive information relating to an interest is not registered in the register, you must indicate that you have an interest, but need not disclose the sensitive information.

**'disclosable pecuniary interest'** (DPI) means an interest of a description specified below which is your interest, your spouse's or civil partner's or the interest of somebody who you are living with as a husband or wife, or as if you were civil partners and you are aware that that other person has the interest.

### **Interest**

Employment, office, trade, profession or vocation

Sponsorship

### **Prescribed description**

Any employment, office, trade, profession or vocation carried on for profit or gain.

Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by M in carrying out duties as a member, or towards the election expenses of M.

	This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority— (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.
Land	Any beneficial interest in land which is within the area of the relevant authority.
Licences	Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.
Corporate tenancies	Any tenancy where (to M's knowledge)— (a) the landlord is the relevant authority; and (b) the tenant is a body in which the relevant person has a beneficial interest.
Securities	Any beneficial interest in securities of a body where— (a) that body (to M's knowledge) has a place of business or land in the area of the relevant authority; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

*"body in which the relevant person has a beneficial interest" means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest; "director" includes a member of the committee of management of an industrial and provident society;*

*"land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income; "M" means a member of a relevant authority;*

*"member" includes a co-opted member; "relevant authority" means the authority of which M is a member;*

*"relevant period" means the period of 12 months ending with the day on which M gives notice to the Monitoring Officer of a DPI;*

*"relevant person" means M or M's spouse or civil partner, a person with whom M is living as husband or wife or a person with whom M is living as if they were civil partners;*

*"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.*

**'non pecuniary interest'** means interests falling within the following descriptions:

- 10.1(1)(i) Any body of which you are a member or in a position of general control or management and to which you are appointed or nominated by your authority;
- (ii) Any body (a) exercising functions of a public nature; (b) directed to charitable purposes; or (c) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union), of which you are a member or in a position of general control or management;
- (iii) Any easement, servitude, interest or right in or over land which does not carry with it a right for you (alone or jointly with another) to occupy the land or to receive income.
- 10.2(2) A decision in relation to that business might reasonably be regarded as affecting your well-being or financial position or the well-being or financial position of a connected person to a greater extent than the majority of other council tax payers, ratepayers or inhabitants of the ward, as the case may be, affected by the decision.

**'a connected person'** means

- (a) a member of your family or any person with whom you have a close association, or
- (b) any person or body who employs or has appointed such persons, any firm in which they are a partner, or any company of which they are directors;
- (c) any person or body in whom such persons have a beneficial interest in a class of securities exceeding the nominal value of £25,000; or
- (d) any body of a type described in sub-paragraph 10.1(1)(i) or (ii).

**'body exercising functions of a public nature'** means

Regional and local development agencies, other government agencies, other Councils, public health bodies, council-owned companies exercising public functions, arms length management organisations carrying out housing functions on behalf of your authority, school governing bodies.

A Member with a personal interest who has made an executive decision in relation to that matter must ensure any written statement of that decision records the existence and nature of that interest.

**NB** Section 21(13) of the LGA 2000 overrides any Code provisions to oblige an executive member to attend an overview and scrutiny meeting to answer questions.

**SUBJECT: FREEDOM OF THE BOROUGH – MR CARL EATON**

---

Wards affected: Borough wide

## **1.0 PURPOSE OF THE REPORT**

1.1 To consider granting the Freedom of the Borough of West Lancashire to Mr Carl Eaton, founder of Skem Menaces.

## **2.0 RECOMMENDATIONS**

2.1 That, pursuant to its powers under Section 249 of the Local Government Act 1972, the Council grant the honour of the Freedom of the Borough upon Mr Carl Eaton, founder of Skem Menaces, in recognition of the eminent service he has rendered to the community and the Borough of West Lancashire.

## **3.0 MR CARL EATON**

3.1 Carl Eaton is the founder of the Skem Menaces Disability Football Club, which has helped to raise more than £50,000 for various charities and good causes. Carl, who was born with Spina Bifida and is a right leg amputee, was inspired to organise the football club in 2009 due to a lack of sports activities available for people with learning disabilities in Skelmersdale.

3.2 The aim of the club, which has more than 50 members, is to provide new experiences and opportunities to its members in order to make them grow, become more confident and have the chance to be able to do things that they wouldn't get the chance to do. Carl has worked tirelessly for the Menaces, who take an active role in supporting and giving back to their local community.

3.3 The Menaces have won numerous awards since their formation, winning a silver trophy at the Special Olympics in Bath in 2013, saw individual members chosen to represent Mencap team GB at the European Championships and won the national award for volunteer of the year through the Sunday Telegraph. In 2015

Carl won the BBC North West Unsung Hero Award when the club was featured on North West Tonight. The club has also received the Points of Light Award from the then Prime Minister David Cameron and were awarded the prestigious Queens Award for Voluntary Service, the highest award given to local volunteer groups in the UK.

#### **4.0 FREEDOM OF THE BOROUGH**

4.1 Under Section 249(5) of the Local Government Act 1972 (as amended) the Council may admit "persons of distinction and persons who have in the opinion of the Authority, rendered eminent services" to the borough as Honorary Freeman. The Freedom of the Borough is the highest honour that the Council can bestow on any citizen or body.

4.2 The proposed Freeman, Mr Carl Eaton, will be in attendance at the meeting to accept the scroll marking the Freedom, following approval of the recommendation at 2.1 above, which will be signed by the Chief Executive, the Mayor and the Leader of the Council. A small reception for Members and invited guests will be held following the meeting.

#### **5.0 SUSTAINABILITY IMPLICATIONS/COMMUNITY STRATEGY**

5.1 There are no significant sustainability impacts associated with this report and, in particular, no significant impact on crime and disorder. The report has no significant links with the Sustainable Community Strategy.

#### **6.0 FINANCIAL AND RESOURCE IMPLICATIONS**

6.1 There will be some financial/resource implications arising from this event in respect of officer and Member time and in the provision of the Freedom Scroll and refreshments, however these will be met using existing resources.

#### **7.0 RISK ASSESSMENT**

7.1 A resolution passed by not less than two-thirds of the Members voting at a specially convened meeting is required to admit the Honorary Freeman.

**EXTRAORDINARY COUNCIL MEETING**

**CONFERRING FREEDOM OF THE BOROUGH**

**1. Preliminary**

At the commencement of the meeting, the Mayor and Deputy Mayor will assume their usual seats wearing their Chains of office. The proposed Freeman Mr Carl Eaton will assume the designated seat allocated at the rear of the Chamber.

**2. Prayers and Apologies - Items 1 and 2**

The Mayor's Chaplain will say prayers following which the Mayor will receive any apologies for absence.

**3. Procedure – Freedom of the Borough - Item 3**

- The Leader of the Council will move the recommendation at 2.1 set out in the report: "That pursuant to its powers under Section 249 of the Local Government Act 1972, the Council grant the honour of the Freedom of the Borough upon Mr Carl Eaton, founder of Skem Menaces, in recognition of the eminent service he has rendered to the community and the Borough of West Lancashire."
- The Motion will be seconded.
- The Leader will then give a short speech explaining why he has moved the motion.
- This will be followed by a speech from the seconder, and other Councillors as appropriate.

#### **4. The Vote**

The Mayor will then put the motion to the vote by a show of hands and provided that there is not less than 2/3rds of the Members present voting for the motion he will declare the motion to be carried.

#### **5. Presentation**

5.1 The Deputy Mayor will move to the seat on his right and the Mayor will invite Mr Eaton to join him on the dais. The Mayor's PA, Ann England, will escort Mr Eaton to the dais. The Mayor will then, on behalf of the Council, present the Honorary Freedom of the Borough Scroll. A photograph of the presentation will be taken.

5.2 The Freeman will assume the position next to the Mayor and will then respond.

#### **6.0 Close**

The Mayor will close the Extraordinary Council Meeting and will invite Councillors and invited guests to a Buffet Reception in the Mayors Room and Cabinet / Committee Room.
