#### FIRE EVACUATION PROCEDURE FOR: COUNCIL MEETINGS WHERE OFFICERS ARE PRESENT (52 DERBY STREET, ORMSKIRK)

PERSON IN CHARGE:Most Senior Officer PresentZONE WARDEN:Member Services Officer / LawyerDOOR WARDEN(S)Usher / Caretaker

#### IF YOU DISCOVER A FIRE

- 1. Operate the nearest **FIRE CALL POINT** by breaking the glass.
- 2. Attack the fire with the extinguishers provided only if you have been trained and it is safe to do so. **Do not** take risks.

#### ON HEARING THE FIRE ALARM

- 1. Leave the building via the **NEAREST SAFE EXIT. Do not stop** to collect personal belongings.
- 2. Proceed to the **ASSEMBLY POINT** on the car park and report your presence to the **PERSON IN CHARGE.**
- 3. **Do NOT** return to the premises until authorised to do so by the PERSON IN CHARGE.

#### NOTES:

Officers are required to direct all visitors regarding these procedures i.e. exit routes and place of assembly.

The only persons not required to report to the Assembly Point are the Door Wardens.

#### CHECKLIST FOR PERSON IN CHARGE

- 1. Advise other interested parties present that you are the person in charge in the event of an evacuation.
- 2. Make yourself familiar with the location of the fire escape routes and informed any interested parties of the escape routes.
- 3. Make yourself familiar with the location of the assembly point and informed any interested parties of that location.
- 4. Make yourself familiar with the location of the fire alarm and detection control panel.
- 5. Ensure that the zone warden and door wardens are aware of their roles and responsibilities.
- 6. Arrange for a register of attendance to be completed (if considered appropriate / practicable).

#### IN THE EVENT OF A FIRE, OR THE FIRE ALARM BEING SOUNDED

- 1. Ensure that the room in which the meeting is being held is cleared of all persons.
- 2. Evacuate via the nearest safe Fire Exit and proceed to the **ASSEMBLY POINT** in the car park.
- 3. Delegate a person at the **ASSEMBLY POINT** who will proceed to **HOME CARE LINK** in order to ensure that a back-up call is made to the **FIRE BRIGADE**.
- 4. Delegate another person to ensure that **DOOR WARDENS** have been posted outside the relevant Fire Exit Doors.

- 5. Ensure that the **ZONE WARDEN** has reported to you on the results of his checks, **i.e.** that the rooms in use have been cleared of all persons.
- 6. If an Attendance Register has been taken, take a **ROLL CALL**.
- 7. Report the results of these checks to the Fire and Rescue Service on arrival and inform them of the location of the **FIRE ALARM CONTROL PANEL**.
- 8. Authorise return to the building only when it is cleared to do so by the **FIRE AND RESCUE SERVICE OFFICER IN CHARGE**. Inform the **DOOR WARDENS** to allow re-entry to the building.

#### NOTE:

The Fire Alarm system will automatically call the Fire Brigade. The purpose of the 999 back-up call is to meet a requirement of the Fire Precautions Act to supplement the automatic call.

#### CHECKLIST FOR ZONE WARDEN

- 1. Carry out a physical check of the rooms being used for the meeting, including adjacent toilets, kitchen.
- 2. Ensure that **ALL PERSONS**, both officers and members of the public are made aware of the **FIRE ALERT**.
- 3. Ensure that ALL PERSONS evacuate IMMEDIATELY, in accordance with the FIRE EVACUATION PROCEDURE.
- 4. Proceed to the **ASSEMBLY POINT** and report to the **PERSON IN CHARGE** that the rooms within your control have been cleared.
- 5. Assist the **PERSON IN CHARGE** to discharge their duties.

It is desirable that the **ZONE WARDEN** should be an **OFFICER** who is normally based in this building and is familiar with the layout of the rooms to be checked.

#### INSTRUCTIONS FOR DOOR WARDENS

- 1. Stand outside the FIRE EXIT DOOR(S)
- 2. Keep the **FIRE EXIT DOOR SHUT.**
- 3. Ensure that **NO PERSON**, whether staff or public enters the building until **YOU** are told by the **PERSON IN CHARGE** that it is safe to do so.
- 4. If anyone attempts to enter the premises, report this to the **PERSON IN CHARGE.**
- 5. Do not leave the door **UNATTENDED.**

- (d) any body of a type described in sub-paragraph 10.1(1)(i) or (ii).

#### 'body exercising functions of a public nature' means

Regional and local development agencies, other government agencies, other Councils, public health bodies, council-owned companies exercising public functions, arms length management organisations carrying out housing functions on behalf of your authority, school governing bodies.

A Member with a personal interest who has made an executive decision in relation to that matter must ensure any written statement of that decision records the existence and nature of that interest.

**NB** Section 21(13) of the LGA 2000 overrides any Code provisions to oblige an executive member to attend an overview and scrutiny meeting to answer questions.

#### HEARING PROCEDURE

- 1. The Chairman introduces the Members and the main Officers.
- 2. The Chairman invites the other parties to the hearing to introduce themselves.
- The Chairman refers to this procedure, which will be followed. (<u>NB.</u> The Chairman will explain that he will allow the parties to proceed without specific time constraints).
- 4. The Chairman asks the Director Leisure and Wellbeing (or their representative) to outline the application.
- 5. <u>Applicant's case</u>
  - (a) The Applicant (or representative) will present their case. This will include general opening remarks followed by calling witnesses.
  - (b) The other parties to the hearing may then ask questions of the Applicant and witnesses, commencing with each Responsible Authority (if present) and concluding with the Sub-Committee.
- 6. <u>Relevant representations Responsible Authorities</u> (if present)
  - (a) Each Responsible Authority (or representative) will present their case. This will include general opening remarks followed by calling witnesses.
  - (b) The other parties to the hearing may then ask questions of each Responsible Authority and witnesses, commencing with the Applicant and concluding with the Sub-Committee.
  - 7. <u>Relevant Representations Interested Parties</u> (if present)
    - (c) Interested Parties will be asked by the Chairman if they wish to elect a spokesperson or representative (or speak individually). Interested Parties will present their case. This will include general opening remarks followed by calling witnesses.

- (d) The other parties to the hearing may then ask questions of the Interested Parties and witnesses, commencing with the Applicant and concluding with the Sub-Committee.
- 8. If several representations (objections) have been received, Interested Parties may question the Applicant and witnesses in turn in an order to be determined by the Chairman. The same order will follow when it comes to the Interested Parties being questioned.
- 9. The Chairman to ask all parties and the Sub-Committee if they have any further relevant questions or comments arising from the hearing.
- 10. Interested Parties, Responsible Authorities and the Applicant to make their closing address in that order (so that the Applicant has the final say).
- 9. The Chairman will ask the Legal Adviser whether there are any other matters to be raised or resolved before the hearing is closed for deliberations.
- 10. The Sub-Committee will retire to determine the application calling the Legal Advisor and Member Services Officer as needed.
- 11. When the Sub-Committee returns the Chairman will announce the decision and give reasons. All parties to the hearing will receive confirmation of the decision in writing within five working days.

Borough wide interest

#### 1.0 PURPOSE OF REPORT

1.1 To consider a Variation application under the Licensing Act 2003 (the Act) for a variation premise licence application in respect of Cactus Rays, Unit 7 Burscough Wharf, Liverpool Road North, Burscough L40 5RZ.

#### 2.0 **RECOMMENDATIONS**

2.1 The Sub-Committee's instructions are requested.

#### 3.0 PREMISES INFORMATION

3.1 Address of Premises:

Cactus Rays Unit 7 Burscough Wharf Liverpool Road North Burscough L40 5RZ

3.2 Premises Licence Holder:

Mr Gary Fletcher

#### 4.0 THE APPLICATION

4.1 On 12 January 2023 an application for a new premises licence was received, a copy of which is attached as Appendix 1 to this report.

#### 5.0 CURRENT LICENCE

5.1 The initial licence for this premise was granted on 21 July 2020 and a copy of the licence is attached as Appendix 2 to this report.

#### 6.0 **RESPONSIBLE AUTHORITY REPRESENTATION**

#### **Environmental Protection**

A representation was received by the Principal Environmental Protection Officer who advised if specific conditions were accepted the representation would be withdrawn. The applicant has not accepted the conditions. A copy of the conditions are attached as Appendix 3 to this report. The representation is made under the Public Nuisance objective.

#### Lancashire Constabulary

A representation was received by Lancashire Constabulary who advised that if specific conditions were accepted the representation would be withdrawn. The applicant has not accepted the conditions. A copy of the conditions is attached as Appendix 4 & 5 to this report. The representation is made under the Crime and Disorder objective.

#### 7.0 PUBLIC REPRESENTATION

7.1 Representations were received by 5 members of the public against this application and are attached as Appendix 6 to this report. The representations raise concerns regarding noise and public order issues. The representations are made under the Prevention of Public Nuisance and Crime & Disorder objectives.

#### 8.0 LICENSING POLICY AND LEGAL CONSIDERATIONS

- 8.1 The Local Authority must have regard to the provisions of the Licensing Act 2003. In addition Section 4 of the Licensing Act 2003 provides that a Licensing Authority must have regard to its Statement of Licensing Policy and to the guidance issued by the Secretary of State under Section 182 of the Act.
- 8.2 As Members will be aware, the four licensing objectives are as follows:
  - The Prevention of Crime and Disorder
  - Public Safety
  - Prevention of Public Nuisance
  - The Protection of Children from Harm
- 8.3 The Act provides that before determining the application, the Licensing Authority must hold a hearing to consider it and relevant representations.

- 8.4 The Licensing Authority in determining the application, having had regard to the application and any representations, may take the following steps if it considers it necessary for the promotion of the licensing objective:
  - (i) Modify/Add conditions in respect of the Variation Application.
  - (ii) Refuse a licensable activity from the Variation Application.
- 8.5 In deciding which of the powers to use it is expected that the Licensing Authority should, as far as possible, seek to establish the causes of the concerns that the representations identify. Any action the Committee may wish to take should generally be directed at these causes and should always be no more than an appropriate response in the cause of promoting the licensing objectives.
- 8.6 In particular, Members' attention is drawn to the following sections of the Policy, which must be read in conjunction with this report:

#### 9.0 HUMAN RIGHTS ACT IMPLICATIONS

9.1 The Human Rights Act 1988 makes it unlawful for a Local Authority to act in a way that is incompatible with the European Convention on Human Rights. The Council will have particular regard to the following convention rights;

#### Article 6

that in the determination of civil rights and obligations everyone is entitled to a fair public hearing within a reasonable time by an independent and impartial tribunal established by law;

#### Article 8

that everyone has the right to respect for his home and family life;

#### **Article 1 of the First Protocol**

that every person is entitled to the peaceful enjoyment of his/her possessions including for example, possession of a licence.

#### 10.0 SUSTAINABILITY IMPLICATIONS

10.1 The Sub-Committee decision has the potential to impact upon the local community affected by the operation of the business. However, the Council's Licensing Policy (required under the Licensing Act 2003), which underpins the Committee's decision, impacts upon many areas within the Community.

#### 11.0 FINANCIAL AND RESOURCE IMPLICATIONS

11.1 No additional financial or other resources are required.

#### 12.0 RISK ASSESSMENT

12.1 The Council has a legal duty to administer the Licensing Act 2003 and is under a legal duty to determine the matter contained in this report. A failure to determine this matter would result in potential legal challenge.



## **ANNEX 1 - MANDATORY CONDITIONS**

The licence is granted subject to the Mandatory conditions for sale of alcohol as set out in the Licensing Act 2003 as amended by the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 and Order 2014.

- 1. No supply of alcohol may be made under the Premises Licence -
  - (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
  - (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
    - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
      - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
    - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
    - d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
    - e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age
  - verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
    - (2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
    - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
      - (a) a holographic mark or
      - (b) an ultraviolet feature.

- 6. The responsible person shall ensure that -
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

### Minimum Drinks Pricing

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula
    - $\mathsf{P} = \mathsf{D} + (\mathsf{D}\mathsf{x}\mathsf{V})$

Where -

(e)

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
  - (i) The holder of the premises licence
  - (ii) The designated premises supervisor (if any) in respect of such a licence, or
  - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.
- (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a
- day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### If the Premises Licence allows Exhibition of Films

- 1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.
- 3. Where
  - (a) The film classification body is not specified in the licence, or
  - (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4. In this section "children" means any person aged under 18; and "film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984(c39) (authority to determine suitability of video works for classification).

# If the Premises Licence has conditions in respect of Door Supervision except theatres, cinemas, bingo halls and casinos

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:
  - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
  - (b) be entitled to carry out that activity by virtue of section 4 of the Act.

    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.

3.For the purposes of this section:

- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

The Mandatory Conditions on this licence are those that where in force at the time the Licence was printed, but that they are subject to amendment by Central Government. Current Mandatory Conditions can be viewed at <u>www.gov.uk</u>.

The premises licence holder should be warned that it is a requirement that they must comply with the Mandatory Condition in force not merely the ones contained on the licence.

# **ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**

The premises shall operate and maintain a digital CCTV system which shall be in use during all times licensable activities are taking place at the premises and comply as follows:

a) The system shall cover all entrances and exits from the premises, in addition to providing recordings from all internal and external areas of the premises used to supply or consume alcohol.

b) The focus of the cameras shall be so as to enable clear identification of persons on the premises

c) The system will be capable of making correctly time and date stamped recordings , retaining said recordings for at least 28 days

d) The Data Controller shall make footage available for viewing and downloading to a Police Officer or authorised officer at any time during which licensable activities are taking place and where such a request is made in accordance with the principles of the Data Protection Act

e) Signage advising that CCTV is in operation will be displayed.

A documented Challenge 25 scheme will be the adopted Age Verification Policy. Challenge 25 will be actively promoted and advertised at the premises and suitable signs will be in place. Any person attempting to purchase alcohol who appears to be under 25 years of age shall be asked to provide acceptable identification to prove that they are 18 years of age or over. Failure to supply such identification will result in no sale or supply of alcohol to that person and the refusal shall be recorded in the dedicated Refusals Register that must be kept to record details of any refused sales. Acceptable forms of identification shall be -

- (a) Photo Driving Licence
- (b) Passport
- (c) Ministry of Defence Identity Cards
- (d) National, including EU Identity Cards
- (e) A PASS accredited holographic proof of age card

A documented training scheme shall be introduced for all staff in a position to serve alcohol. The training must include,

but not be limited to: serving alcohol to young persons, persons who are drunk, allowing disorderly conduct on licensed premises, Challenge 25 and Drug Awareness. The scheme shall be made available for inspection at the request of any Police Officer, Trading Standards Officer or Local Authority Enforcement Officer.

The Designated Premises Supervisor or Premises Licence Holder shall conduct at a minimum yearly training reviews with all members of staff authorised to serve alcohol in order to reinforce this training and to promote best practice. A written record shall be kept of the content of such reviews and be available for inspection by any responsible authority upon request.

An incident log shall be kept to record any notable incidents occurring at the premises such as occurrences of crime and disorder, evidence or suspicion of drug related activity and any requests made for persons to leave the premises. The log should record the date and time, the nature of the incident and the person recording it, the outcome or action taken and a police log number if appropriate. Entries should be completed as soon as practicable and in any case no later than the close of business on the day of the incident. The incident log is to be kept on the premises and shall be produced to a Police Officer or authorised officer on request

All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.

Noise from music and associated sources (including amplified voices) shall not be clearly distinguishable at the boundary of any neighbouring residential premises after 20.00 hours.

No music or speech shall be relayed via external speakers other than for events where the prior approval of the Licensing Authority has been obtained.

Notices shall be displayed at public exits, in a clear and prominent position, requesting that patrons respect the needs of local residents and leave the premises and the area quietly.

The Designated Premises Supervisor and other members of staff to request customers to leave quietly and have respect for their residential neighbours.

No deliveries will take place between the hours of 20:00 and 08:00 hours.

The placing of refuse, such as bottles, into receptacles outside the premises shall take place between 08:00 and 21:00 hours only, so as to prevent disturbance to nearby premises.

The Designated Premises Supervisor or nominated person shall regularly monitor levels of noise in any outside area used for consumption and / or smoking, and advise customers of the need to respect local residents where appropriate. Any patrons continuing to cause any disturbance or disorder will be asked to leave the premises.

Thank you for consulting me with regard to this application.

Environmental Health wish to raise an objection to this application on the grounds of prevention of public nuisance objective.

In summary, the applicant seeks to vary the licence to remove the current condition which states,

"No music or speech shall be relayed via external speakers other than for events where the prior approval of the Licensing Authority has been obtained".

In removing the above condition, the applicant seeks to provide recorded music in the outdoor area daily between 11.00 and 22.00 and live music in the outdoor area on a seasonal basis between April and Sept and the month of December between the hours of 12.00 to 22.00 on a Thursday through to Sunday.

In addition, the applicant seeks to extend the provision of live music at the venue and introduce recorded music in venue. At present live music is permitted on Friday and Saturday between 19.00 and 23.00 and recorded music is not currently specified on the licence.

### External Area

Firstly, and of most concern is the proposal to vary the licence to provide music on a regular basis in the external courtyard area. There, a number of reasons for this as outlined below.

• The applicant has not considered the location of the premises and the proximity of residential and other noise sensitive premises.

- The applicant has not demonstrated they are intending to take appropriate steps to minimise any adverse impacts which are likely to affect the promotion of the objective to prevent public nuisance.
- The applicant has not demonstrated that the noise associated with the provision of outdoor entertainment, which takes place late into the evening or which takes place on a frequent basis at any time can be controlled in a manner that it will not be distinguishable at the boundary of neighbouring residential premises. Environmental Health are aware there are properties within 35m of the Wharf site and therefore there is the significant potential for music noise to impact on nearby residential premises especially when generated outdoors.

On the current licence for Cactus Ray's, there is a further condition stating, "Noise from music and associated sources (including amplified voices) shall not be clearly distinguishable at the boundary of any neighbouring residential premises after 20.00 hours." Environmental Health fail to see how the applicant can comply with this condition if providing music outdoors and therefore there is the potential that this condition will be undermined if the variation is granted.

There is another licence currently in place for the external courtyard area that allows for activity such as live and recorded music. This licence is held by another operator. Environmental Health have concerns that the potential for the cumulative impact of multiple operators operating live/recorded music under separate licences, in a relatively small area could led to competing music output and in addition some ambiguity in who is responsible should complaints/enforcement come forward. A more holistic approach is needed with regards to the utilisation of the external courtyard area for the provision of live and recorded music. The approach that is being adopted by the operator of Cactus Ray's, via this variation, would if granted potentially undermine conditions already in place relating to the wider courtyard licence.

Given the current lack of information and controls identified, Environmental Health do not feel it is possible to support the removal of the current condition stating, "No music or speech shall be relayed via external speakers other than for events where the prior approval of the Licensing Authority has been obtained", until such a time when the concerns have been adequately addressed.

I note from the application (section M) that there is an intention to "serve" outside however there is no information regarding the external service point/bar so I have taken this to mean the consumption within the external seating area which is not a licensable activity. A restriction on the timings the courtyard can be used is already in place on the licence that currently regulates activity in the courtyard area.

### **Internal Area**

The application seeks to significantly increase the timings and frequencies that live and recorded music can take place at the venue. Environmental Health considers the noise sensitive night-time period to be between the hours of 23.00 and 07.00 and noise generated during this period does have the potential to disturb people. Given the proximity to residential premises Environmental Health would expect to see certain control in place to uphold the objective of preventing public nuisance.

At present the application is lacking in that there is no information provided on the ability of the building's envelope to adequately contain music noise or assessment of the weak points in the structure or mitigation of any weaknesses. It has been noted that on a visit to site on Friday 23<sup>rd</sup> Sept 2022 that noise from the operation of live music from Cactus Ray's was audible in the car park area that bounds the nearest residential properties. This would indicate that music can and does, at times escape from the building envelope. Limiting the live music to 23.00 would limit the potential for disturbance.

The application fails to advise the practical noise control measures (limitation devices etc) to be employed to reduce the risk of unacceptable noise associated with the operation of live and recorded music at the premises, especially in the period after 23.00. Given the lack of lobby at the premises there is limited ability to control noise breakout when people are entering and leaving the premises during periods when live and recorded music are taking place.

At present the applicant has not proposed sufficient safeguards within the application to demonstrate the proposal can meet the prevention of public nuisance objective. Environmental Health therefore object to the application on the grounds of prevention of public nuisance unless the following hours limitations and conditions are attached:

- 1. The operating hours of the premises shall be as follows:
  - A. Provision of Live Music -That the provision of live music shall be permitted Indoors only:- in accordance with the hours permitted under the Live Music Act (as amended).
  - B. Provision of Recorded Music (indoors only) -Sunday to Thurs – 11.00 until 23.00 hrs
     Friday and Saturday – 11.00 until 00.00 hrs the next day
     Non Standard Timings: - New Years Eve 12 noon until 01.00 the next day.
  - C. That the premises shall be open to the public: Sunday to Thurs – 09.00 until 23.30 hrs Friday and Saturday – 09.00 until 00.30 hrs the next day Non Standard Timings: - New Years Eve 09.00 until 01.00 the next day.

D. That the sale/supply of alcohol shall be permitted on and off the premises:-Sunday to Thurs – 11.00 noon until 23.00 hrs Friday and Saturday – 11.00 noon until 00.00 hrs the next day

With regards to the above application received on Friday 3<sup>rd</sup> February 2023, I can confirm that Lancashire Constabulary do wish to make representations based upon the Licensing Objective, The Prevention of Crime & Disorder.

Lancashire Constabulary holds 3 separate reports since June 2022 alleging under-age drinking, rowdy behaviour at the premise going unchallenged, drug use and the premises operating beyond it's authorised hours.

Lancashire Constabulary also holds two separate documented visits since July 2022 outlining noncompliance of the current Premises Licence Conditions in July 2022 and unauthorised alcohol sales in December 2022. The visit in July 2022 saw the premises with a Closure Notice under Section 19 of the Criminal Justice and Police Act 2001 which was cancelled on 14<sup>th</sup> August 2022. The visit in December 2022 showed the premises open with customers inside beyond the licensable hours and footage showed transaction being made after this time, given a recent report alleging drug at the premises I administered cocaine wipes, in particular one tables gave indication of strong, recent cocaine presence.


Between January and February 2023, the premises has seen a number of TEN's applied for to extend the Licensable Hours which saw no objection by Lancashire Constabulary, the rationale for this response was that the licensed hospitality sector traditionally sees a downturn in trade during the Winter months and as such the potential for disorder is much lower.

I spoke with the Licence Holder as part of the full variation application and explained my rationale and that I would request conditions around door supervision moving forward should the premises open until 01:45hrs as a means to prevent any potential Crime & Disorder. The Licence Holder was not receptive to this.

Given this, Lancashire Constabulary believe that should the premises be permitted an extension in opening hours that without door supervision conditions it could have a negative impact on the Licensing Objectives.

Please would you consider not extending the hours for this venue (or any others in the wharf location) due to a number of concerns I have and include the following;

\*Noise disturbance/ public nuisance

The Wharf's location is surrounded by residential housing and can be heard clearly and particularly in the summer months when windows may be open.

The way the buildings are located creates an amphitheater effect enabling the noise to be even clearer, add to that the desire for people to sing along and it is even louder.

Even when inside the building the music can be heard additionally, each time the door is opened there is a burst of even louder noise.

\*Anti social behaviour/ public safety

There have been several incidents around the village/ Wharf location involving damage to people's property, including my own when glasses have been smashed on the pavement in front of our drive. Late night disturbances of shouting, fighting and cars been driven erratically.

I do not feel safe walking through the Wharf area after 10pm

Additionally there has been an alarming amount of attacks involving the use of a knife/ weapon and police have been in attendance.

The location of the canal is also a concern as the gate is not locked until very late, I fear this is an accident waiting to happen.

\*protecting children from harm

The wharf is a lovely place to gather and be involved in the events that happen and families are encouraged, however there are several premises able to sell alcohol and young children are present with no additional facilities or activities solely for the children.

Even if a family had enjoyed a meal at one of the venues they would have to walk through the wharf and it's open, public access court yard.

The area was developed to support and encourage whole community inclusion but there is no longer space available outside in order to host alternative events for the community, craft fairs, heritage events, children's events or community events.

Therefore opening times should be considered and not encouraging very late night drinking.

resident of Burscough for 37 years. I would like to make comments on this application.

I find much of this application incomprehensible.

An example can be found on page 14 where the applicant states that the premises would remain open till 24.45hrs. No such time exists. It is to be assumed that the 1.45 made mention of is 1:45 am.

There are references to "amplified acoustic music", this is a contradiction in terms, as acoustic music is defined as "music played without any electrical equipment".

There is great concern regarding behaviour in the immediate vicinity of "The Wharf" relating to antisocial behaviour, drunkenness, violent behaviour, drug taking, and foul abusive language being used in a residential area the current levels of which are unacceptable. So to grant license extensions, would not only prolong the time at these occurrences took place well into the early hours, but may also exacerbate the problem as extending drinking hours is synonymous with a higher incidence of the behaviours mentioned above.

West Lancashire Borough Council have a duty if care to it's Residents to ensure that they can live in a safe and peaceful environment. I am aware of many complaints of antisocial and criminal behaviour in the immediate vicinity of these premises, but have as yet to find any evidence of enforcement by WLBC.

I have recently spoken in person with the Fire Safety Officer for this area, who tells me that no physical inspection of these premises has taken place. I would ask that the Licensing Officer and the Committee which either approves or rejects these licenses are fully satisfied that these premises fully comply with all safety regulations.

This application does not appear to have been completed in a professional manner, if this is a reflection on the professionalism of the applicant, then this should raise concerns.

I object to the granting of this license or for any extension beyond normal licensing hours.

# Burscough Town Councils comments on the Application to vary a premises licence for the following location.

Unit 7 – Cactus Ray Burscough Wharf, Liverpool Road North, Ormskirk, West Lancashire L40 5RZ.

Application. For the following, to remove any condition that states music cannot be played outside within the seating area (?) between 11am – 22.00pm also stated to serve alcohol Fri and Sat until midnight Sunday to Thursday 11am – 12:45am and Friday and Saturday 11am to 1:45am from April to September and December midday – midnight. Live & Recorded music and anything of a similar description through an amplified speaker, late night refreshments and the retail sale of alcohol on/off the premises

Firstly, Burscough Town Council would wish to highlight several concerns about unsocial activities around the Wharf and the Smithy Walk car park next to the Wharf which has caused concerns as to the noise and disturbances to families in the nearby homes, which have been of an unacceptable nature with reports which remain ongoing to the police and WLBC, subsequently a resident has sent a formal complaint to the Local Government Ombudsman and an investigation has commenced.

In looking closely at the Legislation regarding alcohol licence we note the main objectives of the Licensing Act 2003 are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance, and
- The protection of children from harm.

These are important statements and there is a need to ensure these points are being met and where not then action needs to be undertaken to stop the problems being continued.

The following are points have been raised by the Town Council who have looked closely at the application to vary Unit 7 licence: -

- Unit 7 do not currently have permission to use an outdoor facility.
- Unit 7 do not currently have permission to use the first-floor facility.
- Unit 7 do not currently have permission to play any type of music live or through another medium outside.
- Live music outside April to September Fri and Sat until midnight, Thurs until 11:30pm and Sun until 11pm.
- Contradiction as then states Wed until midnight, Fri and Sat until 1am and Sun midnight.
- Existing application states they use upstairs which has seats for 35 people, existing application states they use ground floor space only. Are Cactus Ray currently trading illegally as they also state in their application that they use upstairs in their venue and don't appear to have a current licence for this seating area.
  - 1) Conditions stipulated within the current licence: All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
  - 2) Noise from music and associated sources (including amplified voices) shall not be clearly distinguishable at the boundary of any neighbouring residential premises after 20.00 hours.
  - 3) No music or speech shall be relayed via external speakers other than for events where the prior approval of the Licensing Authority has been obtained.

- On Saturday 25<sup>th</sup> February 2023 it was reported that music could be heard in residential properties until 1.50am (this has been evidenced). accepted by WLBC'
- Objection to the extension of the closing times.
- Objection to outside music either live or via another medium underneath a gazebo.
- Outdoor seating is being used at the moment; concern was raised as to is the relevant licence in place. After looking at the information it was raised that Cactus Ray do not appear to have any plans which currently allow a licence for outdoor seating which is currently available.
- Condition have been put on the existing licence for a reason, no outside music no outside seating. What are the circumstances have changed to allow you to remove these conditions.
- There have been no changes to the infrastructure to stop music from escaping. The seating was a temporary measure during the pandemic as the original application does not allow.
- There are no Artisan Markets anymore, the Wharf are not providing a variation of community activities. This was the original intention when funding was provided from the Arts Council.
- Notes there is a requirement to have extractor fans to remove the smell of cooking food.
- Can it be confirmed that the Fire Safety Inspector has been consulted? and advised accordingly as concerned was raised regarding an outdoor barbeque area.
- Incomplete application, discrepancies on the detail the guidance notes seem to indicate on page 18 the following: *This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary*



# substantially the premises to which it relates. If you wish to make the type of change to the premises licence you should make a new premises licence application under section 17 of the Licencing Act.

We also have concerns about how the initial concept of the Wharf has changed and is no longer operating in the function that Public Money was provided, from the predecessor of English Heritage. This funding was to support the creation of a local historical environment for the use of families. The wharf has over the past two years changed with increased number of licenced premises and the Town Council has needed to undertake research as it was not informed about the changes taking place, it is now not the type of tourist attraction that was in the initial projects concept and subsequently in now more a venue for drinking and music activities and this new application takes this to a none intended environment.

BTC have been working with a local police officer regarding the Police report that was produced on the 7 October 2022 following a visit on the 28 September 2022. This report was produced by Rachel Hines the South Designing Out Crime Officer at HQ Hutton Lancashire, and I understand a copy and its recommendations is now with WLBC. We as a Council hope that WLBC will engage in discussion with the Town Council and residents, to enable a way forward in implementing plans and actions in obtaining a suitable solution to all parties.

BTC recognise that many residents enjoy going to the Wharf and don't cause any problems, we also recognise that the venues employ a number of local staff who need the work and the income from the work. Subsequently we must have a solution to current situation and improve the current situation and not to worsen it.

# Burscough Town Council have previously resolved to support and resolve the anti-social behaviours raised at a Town Council meeting - (8th June 2022.)

Part of problems for the wharf area is the annoyance of loud music for Burscough residents at night when roads have less traffic and other noises have stopped the noise from music travels further when everything else has stopped.



Therefore, taking all of these points into consideration Burscough Town Council would like to object to vary of Licence request from Unit 7 – Cactus Ray Burscough Wharf.
