Dial a crate new appears to be an ex employee David Taggart who is attempting to provoke my annoyance personally by poaching customers on the remit that he still represents and this is a new venture under my own guidance. If he keeps stock it will be at his home address in Lancaster crescent. (I will check number)

He is also most annoying as he is not following "think 25" whilst he seems to know most youths in the area I did not like familiarity of the group's or serving to people without a delivery address in the street.

David is currently applying for a premises licence under the name Suzanne Moore. Although his aunt Suzanne will not EVER be over seeing his activity . He has not registered a company with inland revenue and is called "boozed up" . 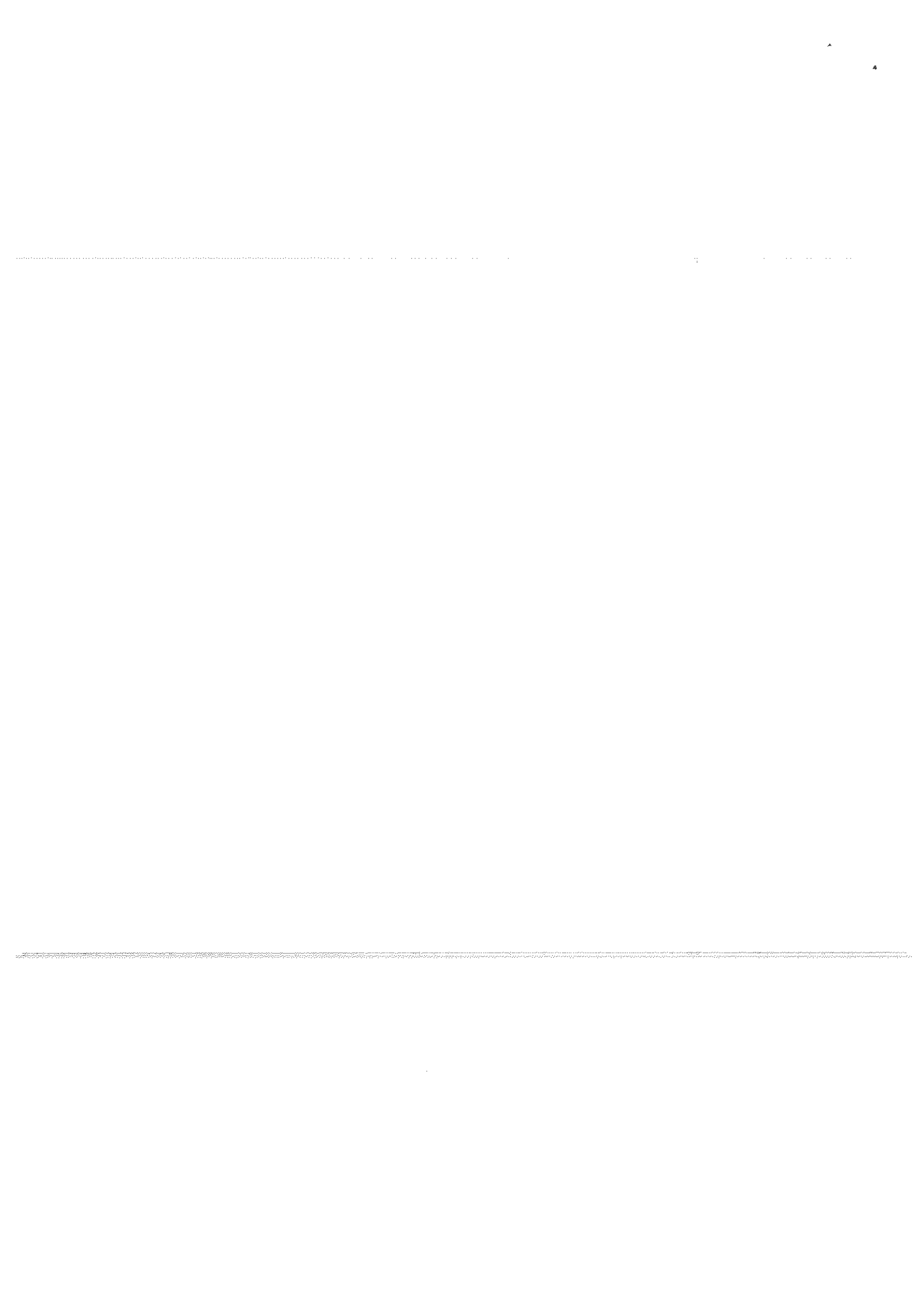

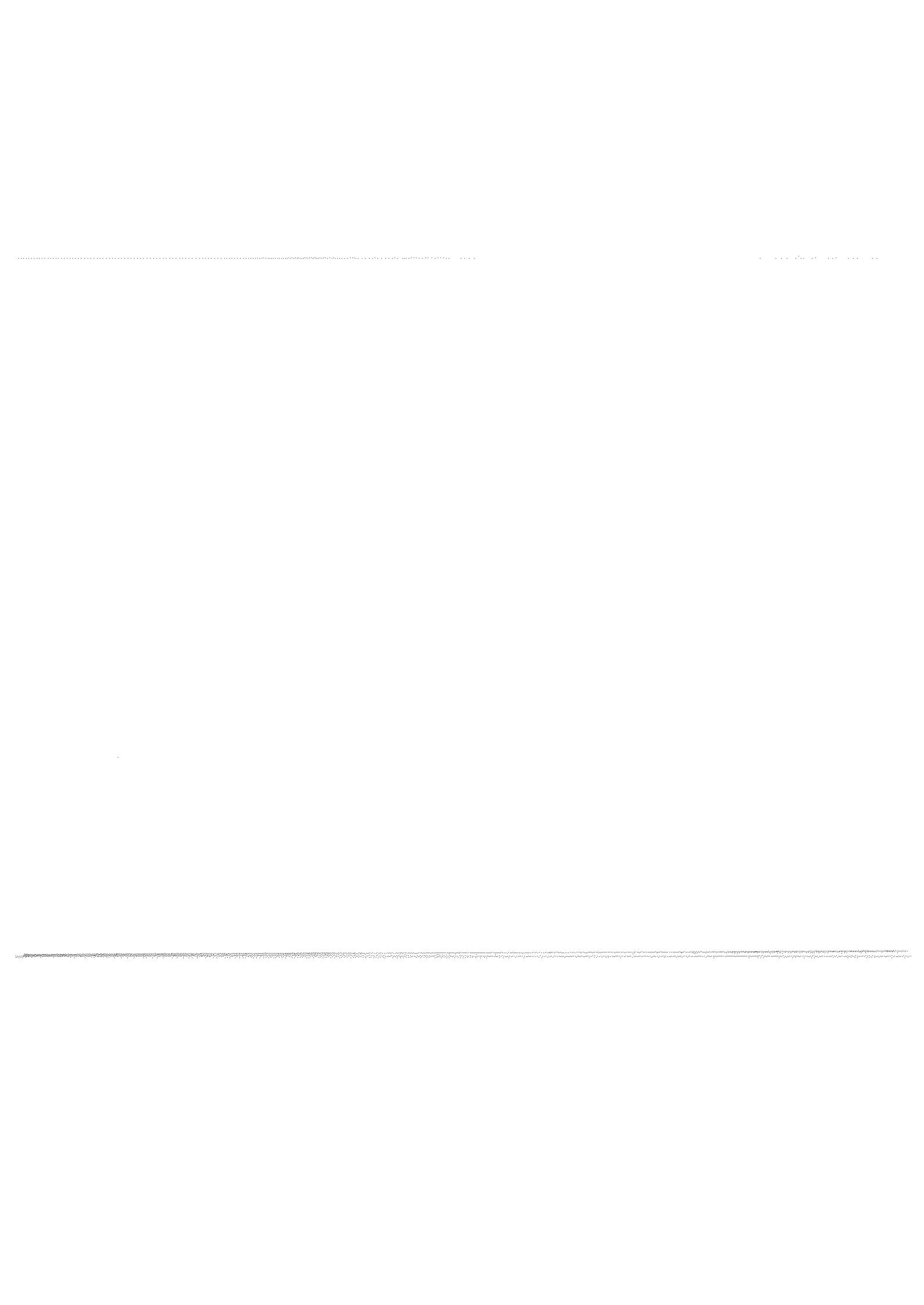
