## **3.0 BACKGROUND**

3.1 Each year our External Auditors produce an Annual Audit Letter. A copy of this year's Letter has been included as the Appendix to this report. The Letter provides an overall summary of the auditor's assessment of the Council, based on all of the work that they have undertaken over the last year.

## **4.0 CURRENT ISSUES**

4.1 The Annual Audit Letter confirms that:

- An unqualified opinion has been given on the accounts, which means that they provide a true and fair view of the Council's income and expenditure for the year and its financial position as at 31 March 2019
- the Council has proper arrangements in place for securing economy, efficiency and effectiveness in its use of resources

4.2 It should be noted that Officers rejected the external audit findings that the value of Council dwellings, land and buildings, and Investment Properties had been misstated and found that the figures quoted by Grant Thornton in their report were not credible.

4.3 Our external auditors will be attending the meeting and will be able to answer any questions that Members may have on the Letter.

## **5.0 SUSTAINABILITY IMPLICATIONS**

5.1 There are no significant sustainability impacts associated with this report and, in particular, no significant impact on crime and disorder.
