TITLE: Section 85(1) of the Local Government Act 1975 – Councillor Gail Hodson

DECISION:

That Councillor Gail Hodson's non-attendance at Council meetings since 16 October 2019 be approved for the purposes of Section 85(1) of the Local Government Act 1972.

- 1. To take any action, including the incurring of expenditure, in connection with an emergency or disaster in the Borough.

REASONS FOR DECISION As set out below

1.0 BACKGROUND

- 1.1 Councillor Gail Hodson last attended a Council meeting on 16 October 2019. By section 85(1) of the Local Government Act 1972, if a member of a local authority fails to attend any meeting of a local authority for a six month consecutive period, his (or her) office becomes vacant, unless that non-attendance is dispensed with prior to expiry of the six month period.
- 1.2 In accordance with the Council's procedures, the Council's Democratic Services Manager, Mrs Jacky Denning, e-mailed Councillor Hodson on 26 February 2020

to remind her of the provisions of the section 85(1) of the 1972 Act. No reply was received and no subsequent attendance was recorded. A further reminder was sent to Councillor Hodson and the Council Leader advised. A (Full) Council meeting, (where all council members are summoned to attend) was due to be held on 1 April 2020. However, due to the outbreak of coronavirus the meeting was cancelled.

1.3 On 15 April 2020 Councillor Hodson advised Mrs Denning that she intended to attend the Council meeting on 1 April 2020 but, due to its cancellation, had been unable to. She also advised that, for personal reasons, she was unable to attend the other Council meetings in respect of which she was due to attend and had instead sent her apologies and arranged for a substitute member to attend. She wishes to remain as a Councillor and wishes consideration to be given to her stated reasons for her recent non-attendance at Council meetings.

2.0 CONSIDERATIONS

- 2.1 I note that the next scheduled Full Council meeting is the AGM on 20 May 2020. Furthermore, I note it is not possible to seek a retrospective dispensation for non-attendance of a councillor. In addition, I consider it is not reasonable or practical to convene an extraordinary meeting of Full Council.
- 2.2 Counsel's advice (appendix 1) has been received from Ms Jacqueline Lean of Landmark Chambers, London. Ms Lean is a leading Local Government barrister. At paragraph 7 of her advice, Ms Lean advises that in light of (1) the imminent expiry of the six month period which would result in Cllr Hodson ceasing to be a member of the authority; and (2) the fact that it would be impractical to convene a meeting to consider a dispensation in the time available, this would be a case where the powers conferred by paragraph 4.21 could be used by me to decide whether a dispensation for non-attendance should be granted.
- 2.3 I have carefully considered the reasons given by Councillor Hodson for her non-attendance. In accordance with the terms of my delegation I have consulted with Leader and Mayor. I have also sought the views of the Leader of Conservative Party and the Leader of the One West Lancashire Party. Their representations are set out in full at Appendix 2. I have taken these views carefully into consideration.
- 2.4 I have also noted the relevant legislative provisions specifically, s.81(1) LGA 1972, and s.60 of the Coronavirus Act 2020 (extension of terms for councillors, with elections scheduled for May 2020 being cancelled) and note that Councillor Hodson, would, notwithstanding consideration of section 85(1) of the Local Government Act 1972 continue in office until May 2021.
- 2.5 Councillor Gail Hodson represents Ashurst Ward, together with two other members. She was first elected into office in May 2012. If her absence were not approved then she would cease to be a member of the authority and the Council would be required to declare her office to be vacant. However, due to the coronavirus outbreak no by-election can currently be held and it is uncertain when a by-election might be able to take place. I am mindful that Ashurst Ward would, under those circumstances, be under represented for an uncertain period of time.

- 2.6 I am satisfied with Councillor Gail Hodson's explanation that she had intended to attend the Council meeting on 1 April 2020 but, due to its cancellation due to coronavirus had been unable to.
- 2.7 I note that Councillor Hodson advises that, for personal reasons, she was unable to attend Council meetings prior to that meeting but note, with some caution, that no further explanation is given. However, on balance, I consider Councillor Hodson's non-attendance at Council meetings since 16 October 2019 should be approved for the purposes of Section 85(1) of the Local Government Act 1972 for the reasons set out above.
- 2.8 The wording of Section 85(1) is such that is not possible, in granting approval for absence, to caveat that approval on the basis that Councillor Hodson attends a particular meeting or is given a "trial period" of less than 6 months. However, if Councillor Hodson were to not attend a Council meeting (which would include any remote meetings organised by the Council) for a further period of 6 months then she would cease to be a member (unless that absence were approved by the Council).
