Council response	There are proposals to provide a cycle route between Ormskirk bus station and Edge Hill University. This will be funded using S106 monies secured from developments at Edge Hill University. The project is therefore excluded from this draft Funding Programme as at present no CIL funds are required. S106 monies have already been used to deliver pedestrian/cyclepath improvements between Ormskirk bus and rail stations.
