


Appendix 3: Consultation Response Analysis




Please tell us in the box below, the reason for your answer

- The policy should enable a rigorous and consistent guide for licensing of a wide range of sex establishments, therefore allowing appropriate monitoring and enforcement action. It will also protect workers involved and residents within the area.
- Better to be regulated than not
- To make the local authority stance on such establishments clear




Please tell us in the box below, the reason for your answer

The Council has set a policy limit of zero for the number of sex establishments of any kind that would be allowed in the Borough. This limit is not binding, as the Council cannot prevent an application from being submitted and determined in accordance with the law, but an applicant would have to demonstrate why the limit zero should not apply. 
Please tell us in the box below, the reason for your answer






Please tell us in the box below the reason for your answer

- I would prefer not to see these types of establishments within the west Lancs area and I am concerned about the enforcement processes that the council may have in place, including resources. Without this it is open to abuse by the business owners.
- Happy its regulated
- I agree that there should be no sex establishments registered/licenced in west Lancs. There are premises in neighbouring boroughs and online shopping therefore the need in West Lancs could be supported in other ways than by having premises in West Lancs.
