67	Aughton	Public	It is not enough that almost all the small interesting shops in Ormskirk have vanished, to be replaced with by coffee shops and charities? Must you also allow sex shops etc. to pollute our once wholesome little market town? For from making Ormskirk more attractive, you would run the risk of actually discouraging young people from applying to Edge Hill University. Not all prospective students and their parents will find your grubby vision of Ormskirk matches their aspirations.

69	Scarisbrick	Public	I just want to say that I agree with the Borough Council's veto on sex establishments in the area. I hope they do not change their minds, it would be a retrograde step by the area, if they were allowed.
70	Ormskirk	Public	I cannot convey my deep concern about the possibility of sex shops and a lap dancing club in Ormskirk. This is a small market town, not a huge impersonal city. Most of our residents would find such things repulsive and demeaning. We have many schools in and around the town, serving primary and secondary school age children. Do we really want them exposed to such shops at such an early age? We also have Edge Hill University close by and should be mindful of the student's vulnerability. I would strongly urge you to think long and seriously before agreeing to these plans.
71	Ormskirk	Public	When I was born in Ormskirk 80 years ago, Ormskirk was a village surrounded by farm land, then it grew into a town, now it is a university town. Please note not a city. If you allow sex shops and lap dancing clubs to invade the town you will end up with more problems than we have now. You will get troublemakers from outside the area coming into Ormskirk. Please note also we do not have a police station let alone policemen on the beat. Who will be there if trouble breaks out between rival gangs? Certainly not you in your cosy offices and as 90% of councillors live outside of Ormskirk, do you not care about us. You were voted in to look after this tumble down town, it's bad enough with the Edge Hill University, without more trouble, or is it a case of not in my backyard thank you very much so we don't care.
72	Ormskirk	Public	I understand that the above policy is due for review and in accordance with the Borough Council's constitutional process, I am writing to express my own concerns regarding any possible changes to the current situation. I fully appreciate that the Council cannot and should not refuse licensing of a sex establishment solely because they or residents disapprove of them in principle, but have read the policy as it stands I believe that refusal would be

			lawful on the grounds that West Lancashire is not an appropriate area for such establishments. Under the legislation, sex establishments cannot be opened near places of worship, schools, parks or any place where children or vulnerable people are in the vicinity and in my view that rules out all of Ormskirk and most of the rest of the Borough. Furthermore, it wouldn't matter how "discreet" the premises were supposed to be, their presence would become known and attract a particular type of clientele to the area, thus changing the family orientated culture of the towns and increasing the risk of unsuitable influences on our young people.
73	Ormskirk	Public	It was with some apprehension that I learned about the possibility of the establishment of a licensed sex shop in Ormskirk and I write to express my concerns about this. There are a number of reasons why the proposal would seem to be inappropriate: 1 Ormskirk is not the sort of town where such an establishment would fit well. 2 the establishment of such a shop would be likely to be at least externally visible to children and to other who would find it distressing. 3. I fear that the establishment would prove damaging to the regular businesses in the town and be off-putting to at least a fair number of visitors. Ormskirk is a wonderful town and I should be very unhappy to see its town lowered by the proposed shop. I ask that the Council do not accept such a proposal. I have been told that the West Lancs Borough Council is in principle opposed to such emporia and has a zero tolerance of them. I hope that this will continue.
