# SUBJECT: TAWD VALLEY PARK MASTERPLAN

Wards affected: All Skelmersdale Wards

# 1.0 PURPOSE OF THE REPORT

1.1 To present Members with a draft Tawd Valley Park Masterplan

### 2.0 RECOMMENDATIONS

- 2.1 That the Tawd Valley Park Masterplan, attached as an appendix to this report, be approved, subject to resource availability, and the project proceeds to the next phase of design and costing of the proposals.
- 2.2 That the approved Tawd Valley Park Masterplan be circulated for a further short term public consultation, and the Director of Leisure and Wellbeing, in conjunction with the Portfolio Holder for Leisure, be authorised to approve any further amendments.

### 3.0 BACKGROUND

- 3.1. Members will recall that in January 2017 a sum of £25,000 was approved to engage consultants to deliver a detailed Masterplan for the Council to progress the development of the Tawd Valley Park Improvement Project.
- 3.2 A 5 stage programme of works was established :-

Stage 1 : Consultation and Development of Masterplan – April to October 2017

Stage 2 : Detailed designs and costings – Oct 2017 to March 2018

Stage 3 : Programming – Jan to March 2018

Stage 4 : Funding - ongoing

Stage 5 : Implementation – April 2018 to 2023(nominally)

Groundwork Cheshire Lancashire and Merseyside were commissioned to undertake phases 1 to 3 of the programme

3.4 An extensive public consultation exercise was undertaken over the Summer including school and college workshops, public events and presentations, press coverage, a visioning event, and an on-line survey. A summary of the main findings of the consultation included :-

3.5 In addition to this consultation the Environment Agency undertook a study to identify and recommend suitable locations for Sustainable Urban Drainage Systems (SUDS), in the form of ponds, which would contribute towards improving the quality of the water in the river.

### 4.0 CURRENT POSITION

4.1 The information from the consultation, augmented by stakeholder comments from local groups and organisations have been used to compile a draft Masterplan for Tawd Valley Park (See appendices 2 to 7 Tawd Valley Park Masterplan, Tawd Valley Park Masterplan Summary Report, Plan of paths, Plan of signs and information boards, Plan of activity zones, Plan of geo location points)

# 5.0 KEY ISSUES

5.1 In developing the draft Masterplan various main issues have been taken into consideration. The quality and availability of existing provision, a good infrastructure and accessibility throughout the park, activities and provision for all, providing a park that will instil pride in the local community, recommendations on future management, and a facility that will significantly contribute to the health and wellbeing of Skelmersdale.

### 6.0 PROPOSALS

- 6.1 Stage 2 of the masterplan process involves the consultants producing detailed designs and costings for the new facilities and improvements in Tawd Valley Park. It is proposed that the current draft Masterplan be approved, with a further opportunity for a short-term consultation in order for the consultants to progress to the next phases of the project, to be reported back to Members in Spring 2018.
- 6.2 Sources of funding will be investigated and, depending on the bidding timescales involved, and the level of funding available, a phased programme of implementation will be produced and reported to Members in Spring 2018.
- 6.3 Current staff resources are being used to manage the initial stages of this project, however, once this scheme reaches implementation stages we would need to consider the on-going requirements. This is an extremely important project for the community of Skelmersdale and engagement with this community is vital. It is proposed, therefore, that park staffing is included in funding bids wherever possible.
- 6.4 It is also important that the local community has an active role in the management of the park and a "Friends" group of local volunteers should be established early in the process to support the initiative.

# 7.0 SUSTAINABILITY IMPLICATIONS/COMMUNITY STRATEGY

7.1. The proposals within the Masterplan will allow for a greater range and availability of healthy outdoor activities for the local community. Community engagement will allow local involvement in the on-going management of the scheme.

# 8.0 FINANCIAL AND RESOURCE IMPLICATIONS

- 8.1 Existing staff resources are being used to manage the initial stages of this project operating alongside a working group of key stakeholders. Consideration will need to be given to staffing levels once this scheme progresses to implementation stage. This will be considered within all funding sources that are investigated to implement the project proposals.
- 8.2 Stages 1 to 3 of the Masterplan process have been funded through a revenue allocation of £25,000

### 9.0 RISK ASSESSMENT

- 9.1 All proposals put forward within this Masterplan will be reliant upon securing sufficient funds to implement. Much of this funding will be from external sources and implementation will be dependent upon timescales and requirements of these funds.
- 9.2 Future management of Tawd Valley Park needs to considered throughout the development process, and recommendations and resourcing will need to be assessed early in the process, to protect investment in the park.
