 - (iii) any change to any non-pecuniary interest on the register
 - (iv) any new non-pecuniary interest to be included on the register.
 - (v) any gift, benefit or hospitality with a value in excess of £100 which you have accepted from any person or body other than the Council.
- 2. Any interests notified to the Monitoring Officer will be included in the register of interests.
- A copy of the register will be available for public inspection and will be published on the authority's website.
