Bodies exercising functions of a public nature

Gifts and Hospitality

You must, within 28 days of receipt, notify the Monitoring Officer in writing of any gift, benefit or hospitality with a value in excess of £100 which **you** have accepted as a member from any person or body other than the Council. The Monitoring Officer will include your notification on the public register.

Sensitive interests

Where you consider that disclosure of the details of an interest could lead to you, or a person connected with you, being subject to violence or intimidation and the Monitoring Officer agrees, if the interest is entered on the register, copies of that register are made available for inspection and any published version of the register will exclude details of the interest, but may stated that you have an interest, the details of which are withheld.

- 1. A member must within 28 days of becoming aware, notify the Council's Monitoring Officer of:
 - (i) any changes to a disclosable pecuniary interest (DPI) previously notified;
 - (ii) any new disclosable pecuniary interest not previously notified.
 - (iii) any change to any non-pecuniary interest on the register
 - (iv) any new non-pecuniary interest to be included on the register.
 - (v) any gift, benefit or hospitality with a value in excess of £100 which you have accepted from any person or body other than the Council.
- 2. Any interests notified to the Monitoring Officer will be included in the register of interests.
- 3. A copy of the register will be available for public inspection and will be published on the authority's website.
