  - any new disclosable pecuniary interest not previously notified.
  - any change to any non-pecuniary interest on the register (iii)
- any new non-pecuniary interest to be included on the register. (iv)
  - any gift, benefit or hospitality with a value in excess of £100 which you have accepted from (v) any person or body other than the Council.
  - 2. Any interests notified to the Monitoring Officer will be included in the register of interests.
  - 3. A copy of the register will be available for public inspection and will be published on the authority's website.
