You must, within 28 days of your election or appointment to office as a member or co-opted member and within 28 days of any new interest, or change to any existing interest notify the Monitoring Officer in writing of your non-pecuniary interests where they fall within the following descriptions.

**Appointments/Nominations to Outside Bodies** 

Bodies of which you are a member or in a position of general control or management to which you are appointed or nominated by the Council.

NIL

Bodies exercising functions of a public nature

Bodies of which **you** are a member of or in a position of general control or management exercising functions of public nature. Include here membership of County and Parish Councils, regional and local development agencies, public health bodies and school governorships.

Bodies directed to charitable purposes

Bodies of which **you** are member of or in a position of general control or management directed to charitable purposes. Include here membership of any charity or similar organisation involved in charitable purposes (e.g. National Truust, Greenpeace, Freemasons etc.)

Influence of public opinion or policy

Bodies of which **you** are a member or in a position or general control or management, where one of the principal purposes includes the influence of public opinion or policy. The Monitoring Officer will include your notification on the public register.

Sensitive interests

Where you consider that disclosure of the details of an interest could lead to you, or a person connected with you, being subject to violence or intimidation and the Monitoring Officer agrees, if the interest is entered on the register, copies of that register are made available for inspection and any published version of the register will exclude details of the interest, but may stated that you have an interest, the details of which are withheld.

Notes: -

- 1. A member must within 28 days of becoming aware, notify the Council's Monitoring Officer of:
  - (i) any changes to a disclosable pecuniary interest (DPI) previously notified;
  - (ii) any new disclosable pecuniary interest not previously notified.
  - (iii) any change to any non-pecuniary interest on the register
  - (iv) any new non-pecuniary interest to be included on the register.
  - (v) any gift, benefit or hospitality with a value in excess of £100 which you have accepted from any person or body other than the Council.
- 2. Any interests notified to the Monitoring Officer will be included in the register of interests.
- 3. A copy of the register will be available for public inspection and will be published on the authority's website.
